

CAMPING WORLD OF HANOVER CAMPER GIVEAWAY SWEEPSTAKES  
OFFICIAL RULES

1. **NO PURCHASE NECESSARY. VOID WHERE PROHIBITED AND IN NEW YORK, FLORIDA, RHODE ISLAND, PUERTO RICO AND CANADA.** Sweepstakes starts August 31, 2019 at 12pm EST and ends September 15, 2019 at 4pm EST. Sweepstakes open to all legal residents of the U.S. (except residents of New York, Florida, Rhode Island, and Puerto Rico) who are 18 years of age or older or of the age of majority in their state of residence, whichever is older, at the time of entry and have a valid driver's license in their State of residence. Employees, temporary employees, independent contractors, interns and their immediate families (spouses and parents, siblings and children and their spouses) or members of the same household (whether related or not) of FreedomRoads, LLC, their affiliates, partners, subsidiaries or parent companies, their advertising agencies and any other company involved with the design, production, execution or distribution of this Sweepstakes are NOT eligible to enter.

2. **TO ENTER.** From September 11, 2019 – September 15, 2019, complete an official entry form available at America's Largest RV Show – Hershey at the Hershey Park Entertainment Complex, Hershey, Pennsylvania (the "Show"). Forms available at each entrance and Sponsor's display, while supplies last, and drop it in the specially marked boxes located at Sponsor's display. Only one entry per person via any method. Sponsor is not responsible for unauthorized human intervention, illegible, incomplete or stolen entries. All entries become the exclusive property of the Sponsor and will not be (returned or) acknowledged. No mechanically reproduced entries permitted. Only entries that have completed or contain the required fields are eligible for the corresponding Grand Prize drawing.

3. **DETERMINATION OF WINNER.** A random drawing for the Grand Prize will be conducted from all eligible entries received by the Pennsylvania RV and Camping Association employee on or about September 15, 2019 at 6pm EST. Odds of winning the Grand Prize are determined by the number of eligible entries received from all methods of entry. Sponsor will notify Grand Prize winner by e-mail and/or phone.

4. **PRIZES.** One (1) Grand Prize 2020 Geo Pro 12SRK. Approx. Retail Value \$14,870. Winner must take delivery at Camping World of Hanover in Hanover, PA by September 30, 2019 or as otherwise arranged by reasonable agreement with Sponsor. No cash alternative to the above prize is offered, but a prize of equal or greater value may be substituted by the Sponsor if the advertised prize becomes unavailable for any reason. Grand Prize is not transferable except to a surviving spouse residing in the same household. Grand Prize Winner is responsible for all applicable federal, state and local taxes, as well as any fees (such as license and registration), insurance and expenses incurred in claiming and using the prize. Persons found tampering with or abusing any aspect of this Sweepstakes, and persons entering or attempting to enter more than once, as determined by the judges, will be disqualified. In the event any portion of this Sweepstakes is compromised by virus, bugs, hackers, non-authorized human intervention or other causes beyond the control of Sponsor, its affiliated companies, participating sponsors, information providers, content providers, subsidiaries, advertisers, advertising agencies, and any other companies involved with or otherwise providing services related to this Sweepstakes which, in the opinion of Sponsor, corrupts, or impairs the administration, security, fairness or proper play of the Sweepstakes, Sponsor reserves the right, at its discretion, to suspend or terminate the Sweepstakes.
